- For innovative, high-flying SMEs with European and global ambitions - aiming at fast international growth
- Only ground-breaking concepts at the last stage before scale-up!
- Bottom up call ("free" topic, with exceptions *) **)
 - Grant 0,5 2,5M€ (70%+ 25%)
 - Blended; Equity max 15 M€
- 12-24 month project
- Funding for both finalising R&D and business development (activities including trials, prototyping, validation, demonstration, testing in real-world conditions, market replication etc.)
- Cut offs
 - 19.5.2020 *) only Green Deal topics **)
 - 7.10.2020 **) 25 % Women Innovators in face-to-face interviews

- Accelerator projects can include activities from TRL6 ->
 - TRL 6-8 funded with grant
 - TRL 9-> funded only with equity
 - Use of equity is at the discretion of the company. It's primary purpose is to enable more efficient commercialization; however, it can also be used to cover the 30 % own funding for the grant phase.



EIC Accelerator Green Deal cut-off 19.5.2020

- For innovations fueling the societal transition towards sustainability while supporting EU's competitiveness and leadership in clean technologies.
- The topic targets high-risk, high--potential SMEs (including startups) from any sector provided that they contribute to Green Deal goals

Projects must support the Green Deal implementation by **significantly contributing** (**quantitative estimate of the contribution required**) to at least one of the following **sustainability goals**:

- Increasing the EU's climate mitigation and/or adaptation ambition
- Supplying clean, affordable and secure energy
- Transitioning of industry to a clean and/or circular economy (including waste prevention and/or recycling)
- Building and renovating in an energy and resource efficient way
- Accelerating the shift to sustainable and smart mobility
- Transition to a fair, healthy and environmentally-friendly food system
- Preserving and restoring ecosystems and biodiversity
- Realising a zero pollution ambition and a toxic-free environment

Projects dedicated to increase the efficiency of fossil fuels technologies or fossil fuels use are ineligible.

Tips for a Successful Proposal

- A good application is **clear, concise and easy to understand**, and tells a logical story
- **Start with a bang!** Problem Solution Competitive Advantage
- In addition to quality content, **the apprearance** should be professional (language and layout)
- All parts of the application (Excellence, Impact and Implementation) must be strong
- Justify your text, don't assume the reviewer is an expert in the industry and/ or business, but doesn't know everything
- Don't repeat the same text too many times

RUSTNESS

- The summary and introduction are read first make them clear and understandable, sell the project right from the start!
- Use graphs and pictures when they clarify and add value
- Reserve enough time to perfect your application competition is tough!
- Ask NCPs and other trusted outsiders to read and comment on your proposal.

EIC Fast Track to Innovation

For close to market innovations with strong business potential and risk

- Funding: 1-3 m€, project duration 36 months
- Grant; funding rate 70% for companies / 100 % for non-profit partners (+ 25 %)
- Small consortia (3-5 participants), for all types of entities:
- Industry driven projects!
 - At least 60% of overall budget to industry or
 - Min 2 industry partners out of a consortium of 3-4
 - Min 3 industry partners out of a consortium on 5

Fully bottom-up, for small consortia

- Free choice of topic breakthrough innovation projects to accelerate market up-take, TRL6-8
- Funding intended for piloting, test-beds, systems validation in real world working conditions, validation of business models, prenormative research, standard setting etc.
- Ready to market in 3 years after kick off!
- Remaining cut-off dates (annual total budget 100 m€ for 3 cut-offs):
 - 9.6.2020

GREEN DEAL Call in Horizon 2020

- Green Deal Call opening 9/2020 and closing 1/2021
- For consortium projects (min 3 participants, 3 countries)

Pre-set themes, consortium projects

- Budget ca. 700 m€ (tbc GD in H2020 = 1 bn€, EIC Accelerator share 300 m€...)
- Call themes currently under preparation
- Work program(s) published in the summer 2020

Horizon Europe is the EU's next research and innovation programme

Green missions:

- The missions in Horizon Europe will mobilise research and innovation, catalyse action, deliver impact, demonstrate solutions, and produce European public goods
- At the same time, they aim to capture citizens' imagination and inspire confidence in the transformations ahead
- Four out of the five agreed mission areas in Horizon Europe directly support the European Green Deal:
 - Healthy oceans, seas, coastal and inland waters
 - Climate-neutral and smart cities
 - Soil health and food
 - Adaptation to climate change and societal transformation

Over 35% of Horizon Europe spending will contribute to climate objectives!
